Director's Notes by Cheri Szcodronski



As we begin a new year, our board, committees, and staff are reevaluating the goals for Preservation Chapel Hill. The Board of Directors and Board of Trustees are nearing the final stages of an update to our bylaws, the Membership Committee is planning a cam-

paign to recruit new members, and the Investment Task Force is exploring the best ways to invest our endowment funds.

Cassie Bennett, our new Program Coordinator, is hard at work with the Development Committee to establish a new sponsorship program, as well as planning several outreach events: April's Modernist House Tour, Fourth of July tours of Carrboro, Voices from the Grave in the fall, the Holiday House Tour in December, and monthly Walk This Way! tours.

Meanwhile, the Preservation Committee is preparing for National Preservation Month

in May with the annual PCH Preservation Awards, the unveiling of the 2014 Endangered Places List, and a new regional preservation symposium in partnership with the Orange County Historic Preservation Commission and the NC Historic Preservation Office. All of these efforts will be capped off with the unveiling of our first ever PCH Preservation Plan, outlining our role in the community, our goals for historic preservation in Chapel Hill and Carrboro, and building on our past suc-

Historic Resource Survey

According to the Department of the Intethe underlying reason for undertaking a survey to identify a historic community's resources is that such resources have value and should be retained as functional parts of modern life. The historic resources of a community neighborhood give it its special character and cultural depth. Some historic resources contain information whose study can provide unique insights into a community's past, and answer broad questions about history and prehistory. In more utilitarian terms, each historic building and structure represents an investment that should be discarded lightly; maintaining and rehabilitating older buildings and neighborhoods can mean sav-

ings in energy, time, money, and raw materials.

This is the immediate reason for undertaking a local historic resources survey: to gather the information needed to plan for the wise use of a community's resources.

PCH is currently conducting a comprehensive survey of Chapel Hill and Carrboro, funded entirely through charitable contributions. So far, we have completed surveys of Gimghoul the and Franklin-Rosemary neighborhoods. We need to raise \$4,000 to complete the expansion the Franklin-Rosemary (Chapel Hill) National Register Historic District, and we need to raise \$20,000 to survey and update west Chapel Hill. Additional phases of this multi-year project will include surveys of additional historic neighborhoods in Chapel Hill and Carrboro.

As Chapel Hill and Carrboro continue to grow at an unprecedented rate, an inventory of significant historic resources is critical to balancing the growth we need with the retention of the elements that define our community. This inventory will become the foundation for the efforts of Preservation Chapel Hill, the Towns of Chapel Hill and Carrboro planning departments, the Chapel Hill Historic District Commission, and the Carrboro Appearance Commission, while the updates to the National Register will open new opportunities for preservation tax credits for business and home owners.

2014 Strategic Goals

Preservation Chapel Hill is dedicated to protecting the character and heritage of the Town of Chapel Hill, and the surrounding community, through the preservation and conservation of its historic buildings and cultural landscapes. So in 2013, the Preservation Chapel Hill Board of Directors, Board of Trustees, and staff worked with Executive Service Corps to reaffirm this organizational mission and establish strategic goals for the next five years. At the end of a series of strategic planning meetings, we established the following set of goals:

- 1. Conduct a comprehensive Historic Resource Resurvey of Chapel Hill & Carrboro.
- 2. Continue our Cemetery Stewardship work with the Town of Chapel Hill Parks and Recreation Department.
- 3. Develop a technical preservation resource network, and be a resource for preservation activities in Chapel Hill and Carrboro.
- 4. Expand and diversify programming to reach new audiences and convey our organizational message.
- 5. Advocate for smart growth and a balance between economic development and retention of historic resources.
- 6. Continue to strengthen relationships with the Town of Chapel Hill, the Town of Carrboro, Orange County, and other organizations in our community.

2014 Preservation Awards

Each May, we celebrate National Preservation Month by recognizing outstanding dedication and commitment to excellence in historic preservation in the Chapel Hill-Carrboro community through our Preservation Awards. Award winners have made significant contributions to protecting America's heritage through their efforts to protect, promote, and preserve Chapel Hill and Carrboro's historic places- the places that make our community truly special. We are now accepting nomination for the 2014 Preservation Awards.

Any individual, business, organization, or government whose efforts have resulted in significant contributions to the preservation, restoration, rehabilitation, adaptive reuse, or interpretation of Chapel Hill's or Carrboro's architectural or cultural heritage are eligible for nomination. Anyone may submit a nomination, and self-nominations are welcome. Nominations may be made in the following categories:

Founders Award: Given in honor of the efforts of PCH co-founders Georgia Kyser and Ida Friday, this award recognizes an individual or organization who has undertaken a significant restoration or rehabilitation project with exemplary sensitivity to historic character.

Young Preservationist Award: This award recognizes the efforts of up-and-coming professionals who have made significant contributions to a local project, research, archival documentation, or University (recipient must be 30 years old or younger).

Preservation Achievement Award: One person really can change the world, so this award recognizes that by honoring professionals who have made significant contributions to the field of Historic Preservation throughout their careers.

Sustainability Award: This award honors individuals or organizations who have implemented new technologies for sustainability and energy efficiency in a rehabilitation project.

Advocacy Award: This award recognizes those who have been leaders in advocacy for preservation issues in the community, leading efforts to promote local architecture and history, effective public policy, and the retention of historic resources.
